Children and young people who are at risk of harm or neglect can sometimes be identified by the following:

- Verbal disclosure
- Observations
- 'Secrets' Adults MUST share information that could indicate a child is being harmed/neglected
- Information from concerned school friends or other adults
- Behaviour
- Emotional well-being
- Self-harm
- Written school work

## HELPFUL TIPS TO PROTECT CHILDREN!

Safeguarding Children and Young People is a sensitive and difficult area and requires all adults to work together.

Good lines of communication are essential. Information must be shared with the Safeguarding Team as soon as possible.

A child may choose to share child protection concerns with you. It is important that the child is heard and what they say is recorded.

You should listen to the child at an appropriate time and try to record word for word what they have disclosed.

Please be factual and remember to state:

- The name of the child.
- The date and time of disclosure.
- Details of the disclosure.
- The author's name, signature and date.
- Remember your statement could be used as evidence.

If a child discloses a child protection concern with you, DO NOT QUESTION FURTHER OR INVESTIGATE.

Please inform a member of the Safeguarding Team immediately and ensure details are recorded accurately and as soon as possible on the school's CPOMs system.
